PRACTICE: One practice round is permitted for each competitor at a special rate of £14.00. This is available from **Monday, 25<sup>th</sup> August 2008**. Practice is restricted to one ball only; tees for practice will be placed slightly forward of the tees to be used in the event. All players are reminded that they must adhere to these requirements and any additional requirements made by the club on the day. Any abuse of these requirements will result in your removal from the event.
